We will request a patient summary from your previous GP Practice or access your Emergency Care Summary, which will provide us with your medication information, however, this can take up to 2 weeks.

## Privacy and Consent

Logan Practice and NHS Lanarkshire take care to ensure your personal information is only accessible to authorised people. Depending on the situation, where necessary we will share appropriate, relevant and proportionate personal information in compliance with the law. This will include essential information being shared with Out of Hours, Paramedics, Accident & Emergency and so on. Any other personal information will only be shared with your explicit written consent. Our staffs have a legal and contractual duty to keep personal health information secure, and confidential.

Reception and administration staff requires access to your medical records in order to do their jobs in supporting the medical staff. These members of staff are bound by the same rules of confidentiality as the medical staff. The practice work with electronic patient records only. Please be aware any paper records sent from your previous practice will securely scanned by Primary Care Division before reaching the practice, your record will then become fully electronic.
